



## **PARTICIPANT USAGE REQUIREMENTS - Kletterwald Aachen 2010**

Every participant must read the Participant Usage Requirements before entering the Kletterwald Aachen. Your signature states that you understand and accept these requirements without reservation and you accept responsibility for all minors.

### **Prerequisites**

The Adventure Park is open to participants with a minimal arm reach of 140 cm and do not suffer from any mental or physical impairments that may impact their control or performance at the Kletterwald. Children under 11 years old must be accompanied by an adult and a maximum of three kids per accompanying adult are permitted (inquire about School class prerequisites).

Persons under the influence of drugs or alcohol may not enter the Kletterwald  
Persons with a body weight greater than 120 kg are also not permitted.

### **Safety**

Every participant must take part in the Kletterwald Safety Training. All directions of the Safety Training are binding. While on the course, participants must always have **TWO carabiners on the safety cord at all times**. During transitions, participants must always have **ONE** carabiner on the safety cord at all times.

If you are unsure at any time while on the course, please immediately ask a Supervisor for help.

In **ADDITION**, the Roller device must be hanged on all zip cord elements. Before using the zip cords, always make sure the arrival area is free of participants! On the zip cord, the legs should always be stretched forward and your braking hand should be **BEHIND** the roller device.

The Supervisors reserve the right to exclude from the Park any persons who do not comply with the Usage rules and to close the Adventure Park in case of environmental conditions (fire, storm, thunder, etc.). In these situations, the Adventure Park is not responsible for reimbursement of admission costs.

Long hair must be held together with a hat or hair elastic. Participants may not take objects with them on the course that may endanger participants or visitors on the ground (camera, watch, backpack, cell phone, etc.).

Only ONE person is allowed on the rope bridges / zip line at a time.  
Maximum of THREE people are allowed on the platforms at one time.

### Equipment

The equipment - 2 carabiners with connecting ropes, double roller device, harness, gloves - are loaned to the participant from the Adventure Park operator for the duration of the visit (~ 180 minutes). Departure from the Adventure Park with the equipment is not allowed. Any damage to the equipment should be immediately reported. The participant is responsible for all equipment loaned out.

### Liability

This Statement of Understanding and Legal Release covers participation in the Adventure Ropes Course offered by Kletterwald Aachen.

I understand in signing this statement that certain elements of this program are physically demanding. I should only participate in the Ropes Course if I am free of medical or physical conditions which might create undue risk to myself or others who depend on me. I hereby state that I am free from such conditions.

I am aware that these activities involve a potential for injury to my person and property. To the extent that I participate in such activities, I do so voluntarily and assume full responsibility for any loss and/or inconvenience resulting from my participation. I further agree to indemnify and hold harmless Kletterwald Aachen and each and all of their officers, directors, employees and agents from any and all liability incurred as a result of my participation. I also agree that this Statement of Understanding and Legal Release shall serve as a complete legal release and assumption of risk for my heirs, executors, and administrators, and for all members of my family, including any minors.

I also give my permission for photos and/or video to be taken of me, and agree that Kletterwald Aachen may use the photos and/or videos, without compensation, for marketing purposes.

If any family members and/or other individuals are listed as authorized participants on the above section of this statement, I hereby declare that I am authorized to sign this Statement of Understanding and Legal Release on their behalf, and understand and agree that they are bound by all the terms and conditions of this document.
